Nurses are recommended to prescribe generically, except where this would not be clinically appropriate or where there is no approved generic name.

- 4 Notes for Nurse Prescribers in Family Planning Clinics - Where it is not appropriate for nurse prescribers in family planning clinics to prescribe contraceptive devices using Form FP10(P) (forms WP10(CN) and WP10(PN) in Wales), they may prescribe using the same system as doctors in the clinic.
