NATIONAL HEALTH SERVICE ACT 2006

The NHS Business Services Authority (Awdurdod Gwasanaethau Busnes y GIG) Directions 2016 (Amendment) Directions 2018

The Secretary of State for Health gives the following Directions in exercise of the powers conferred by sections 7(1), 8(1), 272(7) and (8) and 273(1) of the National Health Service Act 2006(a).

Citation, application, commencement and interpretation

- 1.—(1) These Directions may be cited as the NHS Business Services Authority (Awdurdod Gwasanaethau Busnes y GIG) Directions 2016 (Amendment) Directions 2018.
- (2) These Directions apply to the NHS Business Services Authority (Awdurdod Gwasanaethau Busnes y GIG)(b).
 - (3) These Directions apply in relation to England.
 - (4) These Directions come into force on the day after they are made.
- (5) In these Directions, "the 2016 Directions" means the NHS Business Services Authority (Awdurdod Gwasanaethau Busnes y GIG) Directions 2016(c).

Amendment of the 2016 Directions

- 2.—(1) The 2016 Directions are amended as follows.
- (2) In article 1(4) (interpretation)
 - (a) after the definition of "counter fraud", insert-
 - "the EU Social Security Coordination Regulations" means Regulation (EC) 883/2004, Regulation (EC) 987/2009, Regulation (EEC) 1408/71, Regulation (EC) 574/72 and Regulation (EC) 859/2003;"and
 - (b) after the definition of "security management", insert-
 - "sickness benefits in kind" means "benefits in kind" as defined in paragraph (va)(i) of article 1 (interpretation) of Regulation (EC) 883/2004 but does not include the maternity and equivalent paternity rights or the long term care benefits in kind mentioned in that paragraph".
- (3) For article 16 (Functions of the Authority in relation to the European Health Insurance Card), substitute—
 - "Functions of the Authority in relation to the administration of the reciprocal healthcare system
 - 16 (1) The Authority must, except where paragraph (2) applies, exercise the function of administering any applications, claims or registrations made in relation to sickness

benefits in kind under the EU Social Security Coordination Regulations in accordance with instructions given by the Secretary of State for Health and Social Care.

(2) The Authority is not directed to exercise the function in paragraph (1) insofar as that function is carried out by the NHS Commissioning Board pursuant to regulation 3 of the National Health Service and Public Health (Functions and Miscellaneous Provisions) Regulations 2013.".
